

# Use of Twitter Policy Bretherton Endowed CE Primary

"Walking in the footsteps of Jesus with our Christian family, we learn, grow, achieve and flourish together in God's love."

This policy is for Bretherton Endowed CE Primary School and The Hub, Bretherton Endowed Out of School Provision.

# Rationale

The rationale of this policy is to explain acceptable use of Twitter relating to the Bretherton Endowed CofE Primary School Twitter feed @BrethertonEP for staff, children, parents and governors. The policy will therefore aim to explain the purpose of Twitter in our school and the benefits that will arise from its proper use, and also avoid any potential pitfalls using this technology.

# What is Twitter?

Twitter is used primarily as a method of communication made up of 140 characters called a 'Tweet'. Tweets tend to reference people, places, and/or activities to which the said referee can respond. Tweeters either directly reference another person or broadcast information to which others can reply and respond. Twitter users are able to follow or be followed. To follow somebody/thing ensures that all of their activity and comments appear in the followers news feed. The obvious benefit of having followers is that the information you broadcast is instantly distributed into their news feed. Users can also private message each other when they don't want conversations to appear. @BrethertonEP will not enter into private discussions with others.

# What is the primary purpose of @BrethertonEP?

• @BrethertonEP will be used principally to be followed by staff, parents and other professionals in order to promote the excellent work by staff, children, parents and governors.

• Similarly, it will also contain information detailing special events in school. The aim of this is to run alongside more traditional methods like sending home letters, texts and not to replace it.

# Who controls content for @BrethertonEP?

The uploading of content for @BrethertonEP will be controlled by the Senior leadership team initially and rolled out to teaching staff over the first year.

# Who can follow @BrethertonEP?

• @BrethertonEP is a public account

The school retains the right to block any followers who post content that is deemed to be inappropriate (see below).

# Who will @BrethertonEP follow?

• In order to protect itself from inappropriate content being distributed into its news feed, @BrethertonEP will not actively seek to follow other users. However, exceptions may be made where following an @ handle has obvious benefits to the school. For example the DFE or Ofsted

• @BrethertonEP sees itself more as a distributor of information to those who follow it and not as a receiver of information.

#### What information will be shared @BrethertonEP?

• @BrethertonEP is solely sharing information and events involving Bretherton Endowed CofE Primary School.

• The @BrethertonEP Twitter account will retain a professional boundary at all times, no personal information will be tweeted.

• Tweets that promote our school in a positive light may be retweeted.

#### When is it acceptable to respond to tweets?

- @BrethertonEP account will not reply to all 'replies' on Twitter.
- @BrethertonEP is solely for information and will not discuss any school matters.

#### How to protect @BrethertonEP

• @BrethertonEP username and password are only known by the staff.

#### When will @BrethertonEP be active?

• @BrethertonEP will be active between the hours of 8am-8pm Monday to Friday

• Tweets will only be made outside of this time for school events (e.g. sports, residential trips, performances) or to share urgent school news (e.g. closures due to adverse weather).

### What information will be shared relating to individual pupils at the school?

• Photographs

- Work produced by pupils (not identified by name)
- @BrethertonEP will only post an individual child's forename and first letter of their surname
- Individual achievements of pupils, both in and out of school (with consent from parent/carer)

# Do parents/carers have to provide consent for information relating to their child to be published by @BrethertonEP?

• The school will use consent provided under our school consent document which parents complete when enrolling their child at the school.

• Parents/carers who have specific concerns about information relating to their child being posted on @BrethertonEP should address these to the Headteacher.

# What is inappropriate content and referencing and how will it be dealt with?

@BrethertonEP welcomes any referencing, mentions, or interactions that position the school in a positive light only.

Therefore, Bretherton Endowed Primary School deems any of the following as inappropriate:

• Comments that aim to undermine the school, its staff, pupils, parents, governors or others affiliated with the school.

• Offensive language or remarks aimed at the school, its staff, pupils, parents, governors or others affiliated with the school.

- Unsuitable images or content posted into its feed.
- Unsuitable images or content finding its way from another's account into the @school\_ws feed.
- Images or text that infringe upon copyright.

Any inappropriate content will be deleted and its users will be removed, blocked, and, depending on the nature of the content, reported to Twitter. Furthermore, incidents of a more serious nature may be reported to the appropriate authority.

# How will safer internet be promoted alongside Twitter?

@BrethertonEP is primarily for parents and guardians. However, the school's use of Twitter promotes the careful and safe use of social media to the children. In addition to Internet Safety week, e-safety will be reinforced through any use of computing in other subject areas. If a child requests to follow @BrethertonEP the school Computing Lead will be notified. Children will not be encouraged to access or participate in Twitter through school.
